

TOWN OF WILTON
SELECTMEN'S MINUTES

Date: May 23, 2016
Time: 6:30 P.M.
Place: Town Office
Present: Selectmen William F. Condra and Daniel E. Donovan, III. Recording Secretary Pamela Atwood. Chairman Kermit R. Williams was absent.

The meeting was called to order at 6:30 P.M. by Selectman Condra who is sitting in for Chairman Williams.

Potential TB Exposure

A conference call with Tammy Denver of Primex was made to have a discussion regarding the recent Workman's Compensation claim denial. Ambulance Chief Gary Zirpolo and Police Chief Brent Hautanen joined the Selectmen in the conference call.

Selectman Condra began the discussion by saying that the Town has concerns over the potential TB exposure claim denial. Handouts were distributed. Tammy explained the RSA's saying that Primex follows case law and nothing has changed with this law. Chief Hautanen stated that without doing the initial testing there would be no way to link it back to the initial exposure. There was a discussion about airborne and blood borne exposures. Chief Zirpolo stated that they followed the standards put out by the CDC, OSHA, and their physicians when they got tested after the potential exposure. He feels that Primex is covering below the standards. Tammy said that Primex is bound by the statutes. Other exposure cases were discussed. Ms. Denver said that the protocol and statutes don't follow each other and that Primex understands the frustration; but they must follow the statute. She said there would need to be a legislative change. Primex looks at each case on a case-by-case basis. After further discussion, Selectman Condra confirmed that there was nothing new to add to the discussion and the Select Board would discuss it among themselves. Tammy reminded the Selectmen that they can appeal to the Department of Labor. The phone call was ended. Selectman Condra said that Primex is providing the minimum coverage stated under the statute. Chief Hautanen is concerned that if something else occurs he must now worry whether his employees are going to be covered. Selectman Donovan will contact Attorney Little and report back to the Board in two weeks.

Block Party

Chris Fredette of Maple Street was the next agenda item. Mr. Fredette was not present but Jeff Stone stood in for him. Mr. Fredette's request is for permission to close down a section of Tremont Street for parking during a graduation block party they are hosting. Chief Hautanen remained at the meeting to tell the Selectmen that he has no objections to their request. Further details of the event were given. The Selectmen had no objections.

Motion: Selectman Donovan moved to allow the road closure as discussed. Selectman Condra seconded the motion. A unanimous vote followed. Motion carries.

Metal Detection at Carnival Hill

Jeff Stone had another request which he received from the Conservation Commission's webpage. Someone was asking permission to use their metal detector on Carnival Hill. The Selectman asked a few questions and were satisfied with the answers and made a motion.

Motion: Selectman Condra made a motion to respond in the affirmative to the request. Selectman Donovan seconds. A unanimous vote followed. Motion carries. Jeff will write the response.

Riverwalk Impact Fee

Jim Quinn was on the agenda to discuss the Impact Fees that had already been paid on his Riverwalk subdivision. Mr. Quinn did not show up for his appointment. Jerry Green was in the audience and on the Select Board at the time and so he gave a brief history of the situation in Jim's absence.

Dawn Tuomala also spoke saying that it was her impression that the fees the Quinn's paid back in 2013 were the Impact Fees and no others were to be assessed. Selectman Condra agreed that if they were to charge additional per-lot Impact Fees it would be double dipping. He explained why John did what he did, saying that it was a misunderstanding.

Motion: Selectman Donovan moved that the Select Board has determined that no additional Impact Fees are due for the Riverwalk subdivision because of the \$10,400 received, and the improvements made on Proctor Road. Selectman Condra stated that there was no impact fee schedule at the time of this subdivision, and the Town does not intend to impose the fee retroactively. Selectman Condra seconded the motion. A unanimous vote followed. Motion carries.

Selectman Condra moved to enter into a non-public session at 7:21 P.M. per RSA 91-A:3,II (e). The motion was seconded and voted in the affirmative.

The regular meeting was back in session at 7:41 P.M.

Economic Development

Selectman Donovan spoke to Andre Garron and will have more information to present next week.

Old/New Business

Selectman Donovan will speak to Attorney Little regarding a housing code enforcement issue.

A motion was made to adjourn the meeting at 7:58P.M. by Selectman Donovan, seconded by Selectman Condra, followed by a vote with all in favor.
