## Minutes for December 14, 2015

The Wilton Conservation Commission held its regular monthly meeting on Monday, December 14, 2015, at 7:00 pm in the Town Hall Courtroom.

- Chairman Bart Hunter **called** the meeting **to order** at 7:00 pm.
- Present: Spencer Brookes, Bill Maher, Jeff Stone, Joe Broyles, Bart Hunter, Alan Preston.
- Visitors: There were no visitors.

### Old Business:

- Minutes of **November 9<sup>th</sup>**, 2015 meeting: **Bill moved to accept** the minutes, **Spencer seconded**, the **motion passed**.
- Budget & Expenditures: Bart: the **presentation to the Budget committee went well**. They **only asked about \$3000** for, among other things, **enlarging the Frog Pond Conservation Area parking area** on Maple St., which he wasn't able to recall at the time. Allan: Pam (BoS Admin Ass't Atwood) says **we've spent \$1000. so far on Whiting Hill Rd. and 80 Maple St. right-of-way** culverts; that **we have \$750 left** in the maintenance budget. Bart: We **need a name for the 80 Maple St. ROW** to avoid confusion with the Maple St. public entrance to the Frog Pond Conservation Area.
- ZBA: (nothing to report)

- Frog Pond & DES: (nothing to report)
- Forest Management: Bill: There is a **new application** this month for **lot H-012**.
- Wildlife sightings: Bill: **Barred Owl, Broadwing**; Alan: **Gray Fox**; Joe: **Pheasant**.
- Update on Conservation Plan: A final copy was **delivered** to us **by NRPC**. It still **contains errors**, some of which we had already reported to them. It **needs to be proof-read and corrected**. We will **continue tonight's meeting** for that purpose on **Wed, December 16, 2015 at 7:00 pm**.
- Property Monitoring: Bart, Joe, & Jeff are to meet Tue, December 15, 2015 at 8 am at Four Corners Farm to **monitor Four Corners Farm, lot 54-9** [ed note: my interpretation from the tax map] **boundaries**, and **foundation** for a **shed** to be attached to the barn on that lot.
- Letterhead Update: Jeff: The **BoS** said that as the **WCC is an officially appointed town commission**, we **can and should have a letterhead**, which **may include the town seal**, as long the letterhead is clearly that of the
