Thank you for giving Fort Mountain Companies the opportunity to provide a timber harvest proposal for the Reservoir sanitation harvest. Enclosed please find bid pricing and suggested volumes for trees that may be cut.

Please keep in mind this volume estimate is based on a brief walkthrough intended to provide an idea of <u>total</u> harvest value. The volumes are not set in stone though I feel they are on the conservative side of things.

Attached are some additional notes for your consideration in relation to this proposal after spending an hour reviewing the site this morning.

We would be able to fit this small project in between one of our scheduled jobs, pending paperwork filing, harvest layout, and depending on soil /weather conditions. I anticipate this would be around mid to late December given current progress and schedule. I would suggest the contract period go through spring 2022.

## FMC Reservoir Sanitation Harvest Proposal Notes:

- The white ash is threatened on the site. Some has already died, others may be infested with EAB. It may be advisable to cut easily accessed white ash saw timber while equipment is on site. Optional...
- Some poorly formed white pines damaged from the 2008 ice storm, not removed
  in the last harvest could be cut to improve aesthetics and forest health. A load of
  white pine could easily be produced cutting them and a few other select mature
  trees to generate the suggested volume. Optional... Just disregard if not desired.
- Extent of invasive plants is more widespread than we have discussed so far. I do not think there is much to be done without great expense and effort to control them. Making sure they don't leave the site will be important
- Low volume of chips will be produced from this sale. If it is desired chips be left on site for use in trails etc. \$20.00 per ton charge for estimated volume left will be assessed. \$600.00 per tractor trailer load roughly... If we are just chipping a small amount of leftover top wood there would be no charge. If chipping is not a requirement we can disperse brush or discuss where it would be placed.
- The smaller scale nature of this project limits what we can offer. In your decision making process of choosing a logger please consider this proposal includes my services. The logging crews are our own, which I have full control of what happens in the woods. They are guys I work with daily and know what to expect. Changes can be made immediately.
- There is another load or two of red pine around the back side of the reservoir near the rope swing. At this point I think the impact required to reach it would outweigh the benefit of cutting it. Some of the trees are on a very steep bank impossible to reach with equipment without impact to soils adjacent to the pond. These may need to be left to natural processes at risk of eventually ending up in the pond.
