General Information and Award / Submission Procedures

1. Key Dates

Bid deadline: November 21, 2022

Vehicle Removal Deadline: December 31st

2. Process Description

The Town of Wilton is seeking sealed bids in compliance with the wishes of the Wilton Select Board. An open "**Request for Bids**" process was selected as a way to fairly offer the vehicle in question to interested members of the public while ensuring the Town of Wilton gains any residual monetary value in the vehicle.

3 Obtaining RFB Documents

7. Bid Award

The Wilton Select Board will award the vehicle to the bid that overall represents the best value and aligns with the interests of the Town of Wilton. Payment must be received by the Town of Wilton prior to pickup.

8. Vehicle Condition

The vehicle being sold and its associated equipment are being sold "as is" and the Town of Wilton explicitly does not guarantee or make any warranty or guarantee of performance or condition beyond what is listed under the description in **Section 10**.

9. Vehicle Pickup

The winning bidder must arrange to pick up the vehicle within 30 calendar days of bid award. Failure to pickup the vehicle within that period will be immediately disqualifying, and the Select Board will award to the bid to the next lowest cost proposal.
